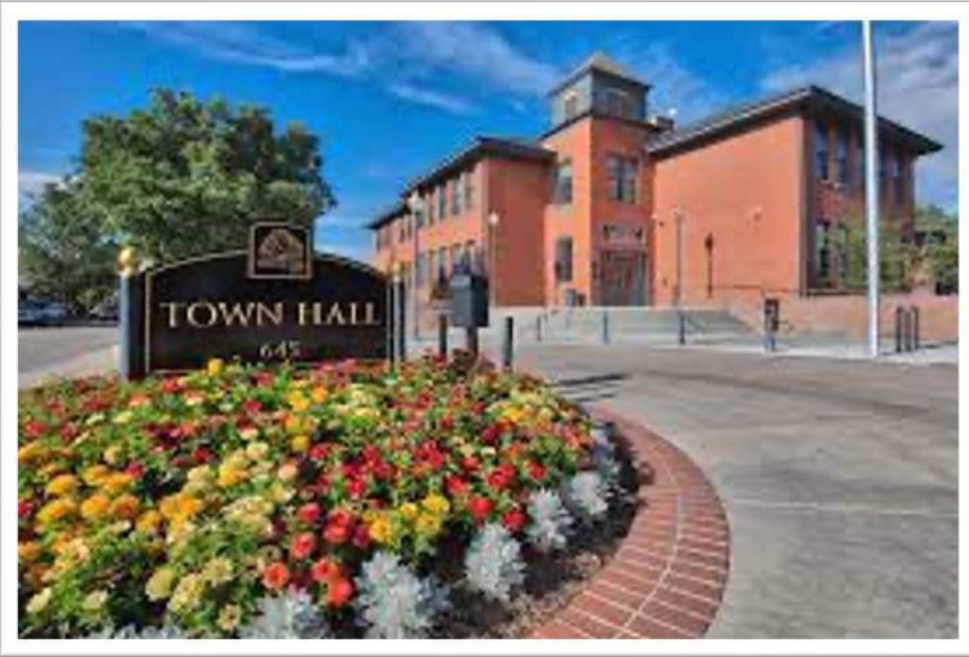


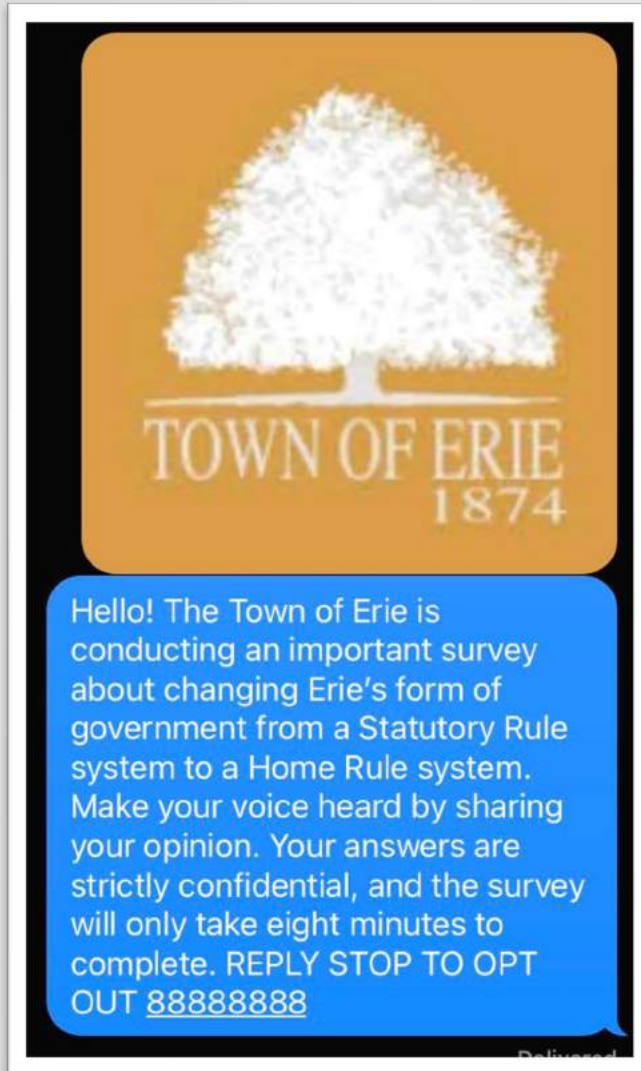
Town of Erie Home Rule Voter Opinion Survey



January 10th to 19th, 2022



Methodology



Magellan Strategies is pleased to present the results of a live telephone and online survey of 1,531 registered voters in the Town of Erie, Colorado.

The interviews were conducted from January 10 – 19, 2022. The overall survey responses have a margin of error of +/- 2.41% at the 95% confidence interval. Population subgroups will have a higher margin of error than the overall sample.

The survey results were weighted to be representative of the voter turnout demographics within Erie, CO for a midterm election cycle.

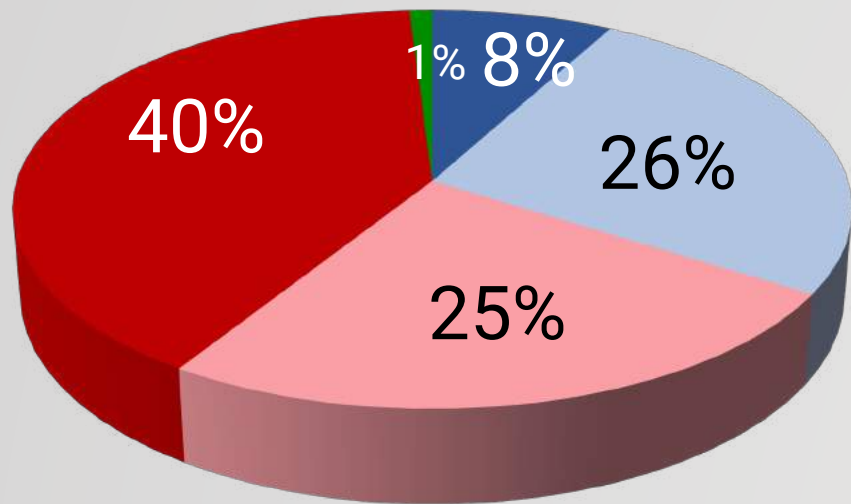

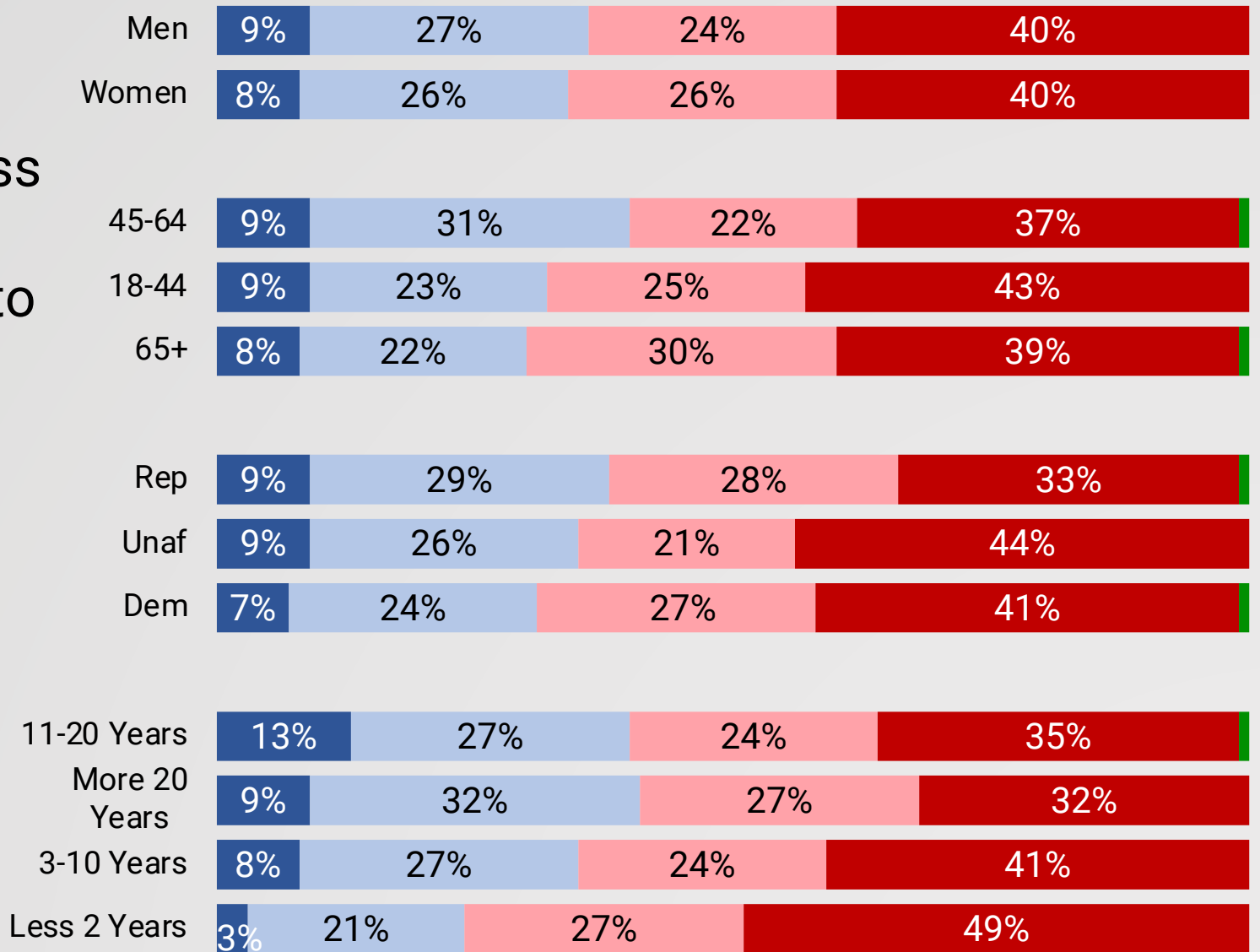

How familiar are you with the Town's efforts to educate and inform residents about the process of changing Erie's form of government from Statutory Rule to Home Rule?



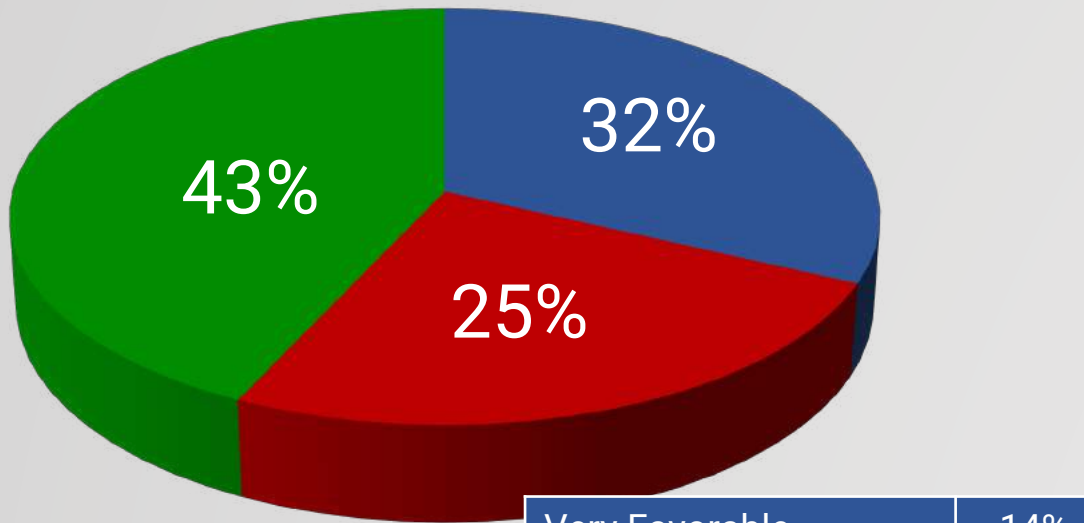

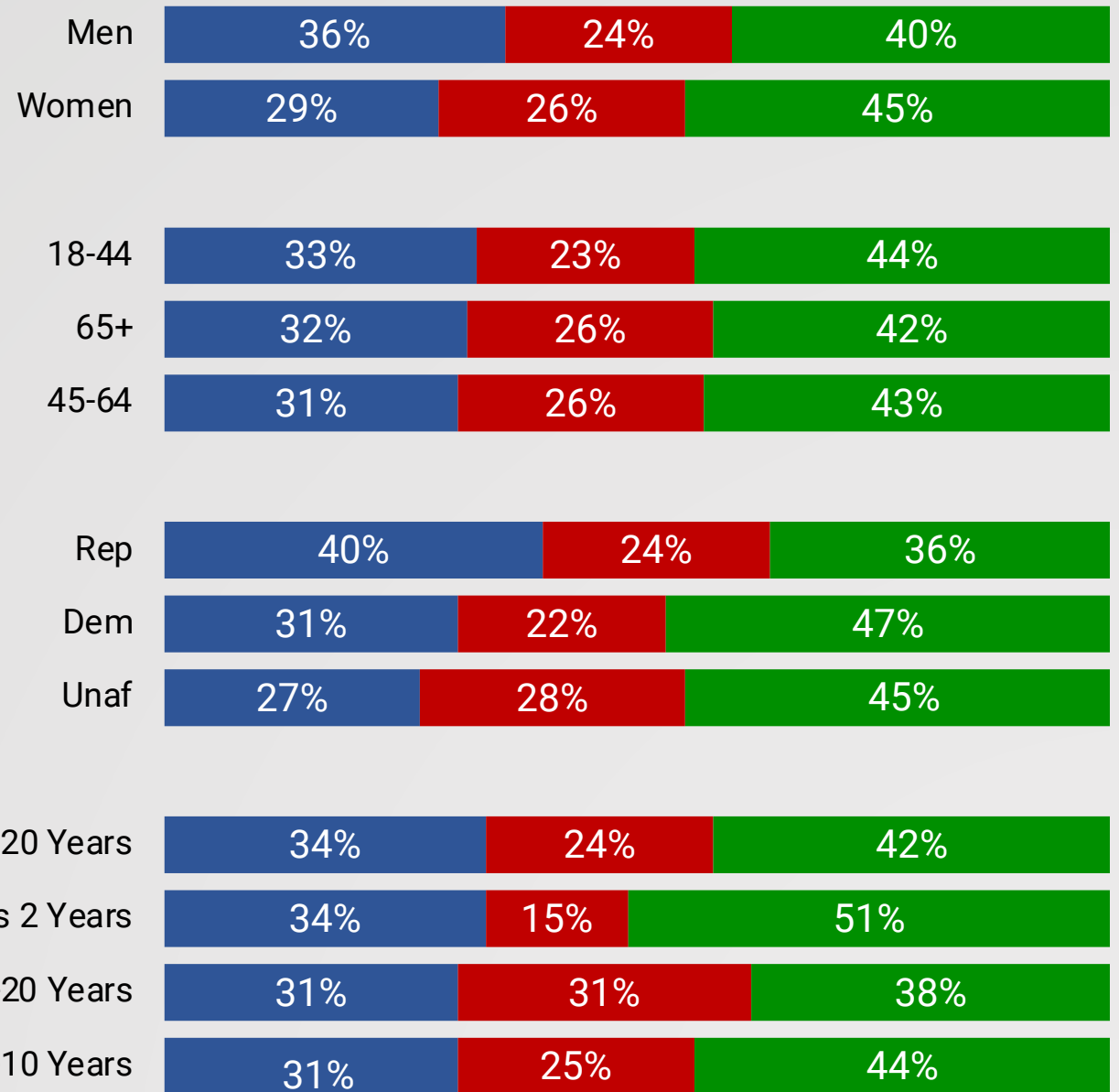


Based on your current knowledge, do you have a favorable or unfavorable opinion of a Home Rule form of government?

Town of Erie Home Rule Ballot Question

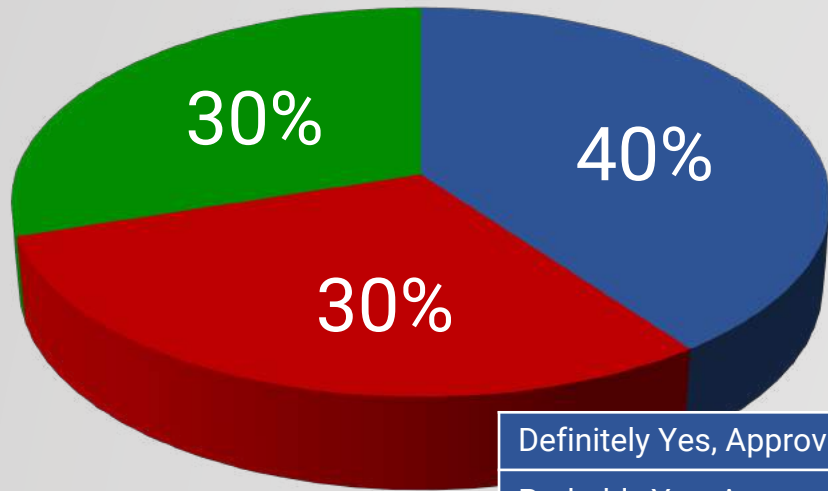

In that same election and on the same ballot, voters will also be asked to vote for residents to serve on the Home Rule Charter Commission.

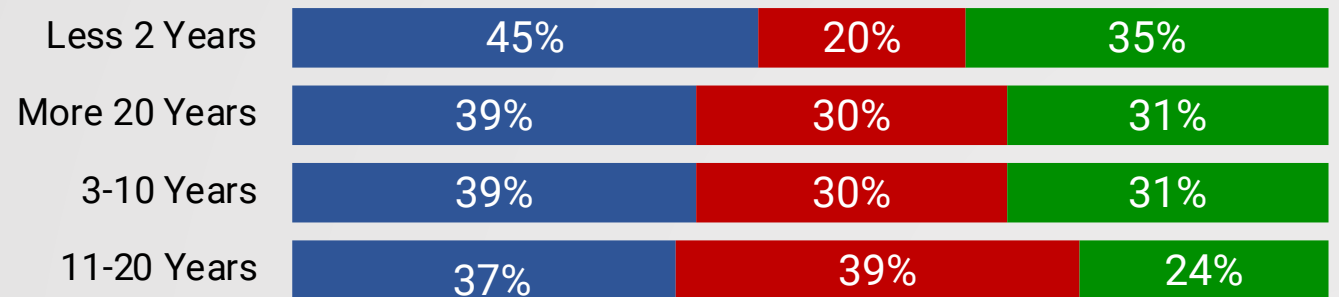
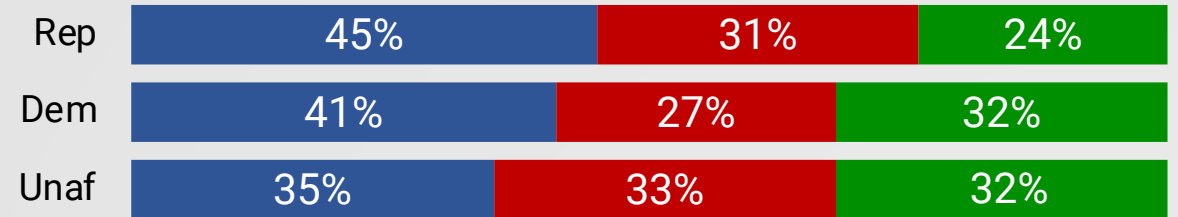
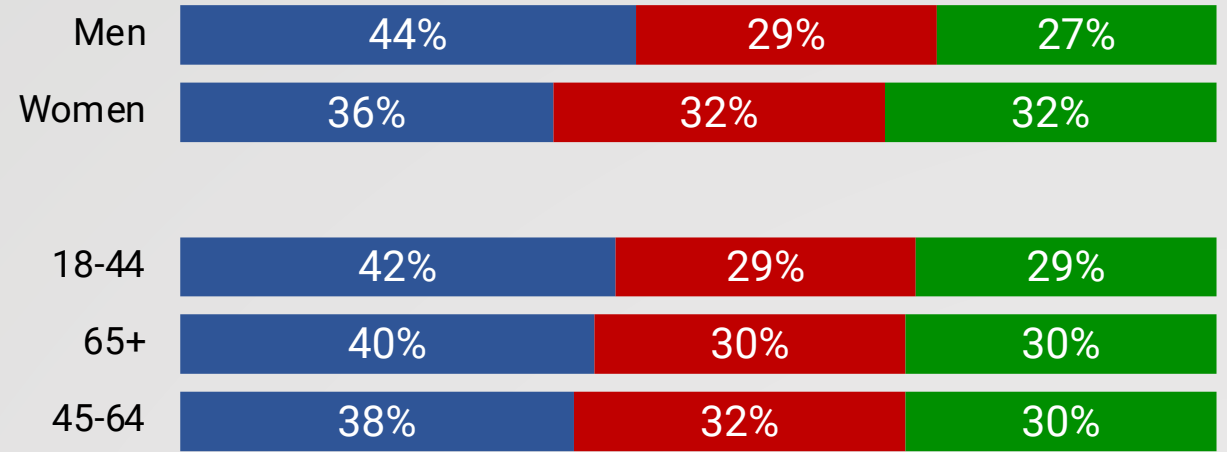

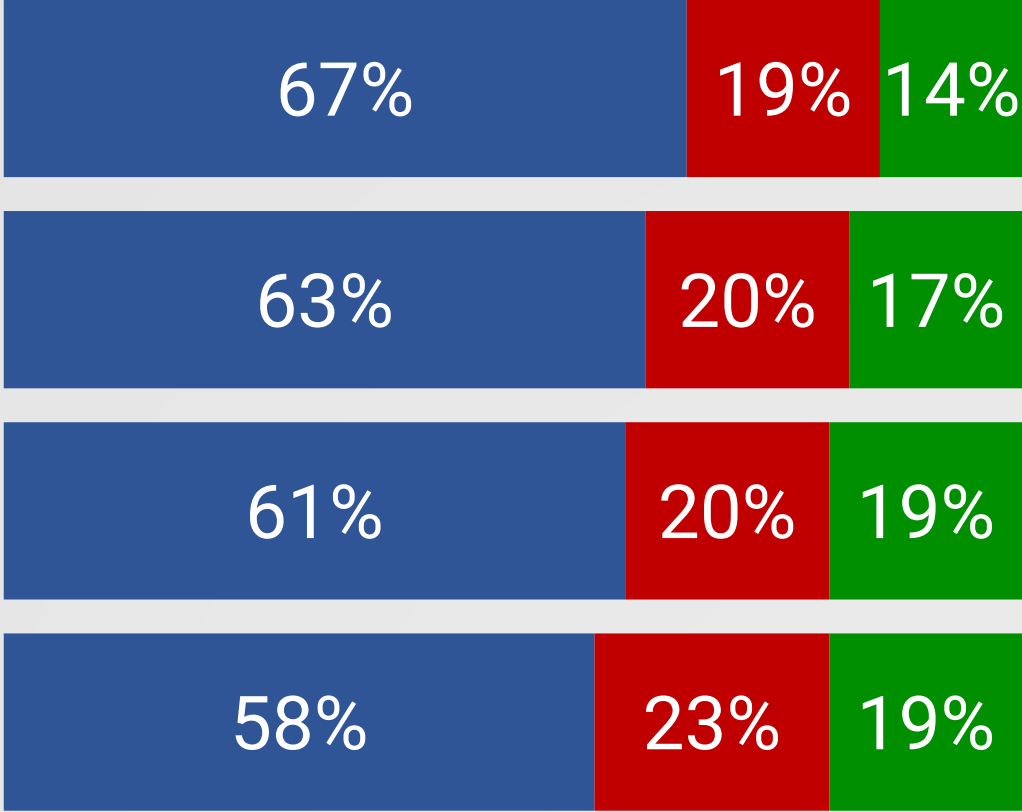
Erie Home Rule Education & Information Questions

Successful Home Rule Charter Commissions usually have a politically diverse group of members to ensure all voices and opinions are represented when drafting the new Town charter.

Ninety-three percent of Colorado residents live in a Home Rule community.

Under a Home Rule form of government, the Town of Erie still must abide by the TABOR Amendment, also known as the Taxpayer Bill of Rights. This requires Erie voters to approve any future sales tax or mill levy increases.

After the Home Rule Commission members draft a new Town charter, Erie voters would hold an election and vote to approve or reject the charter.

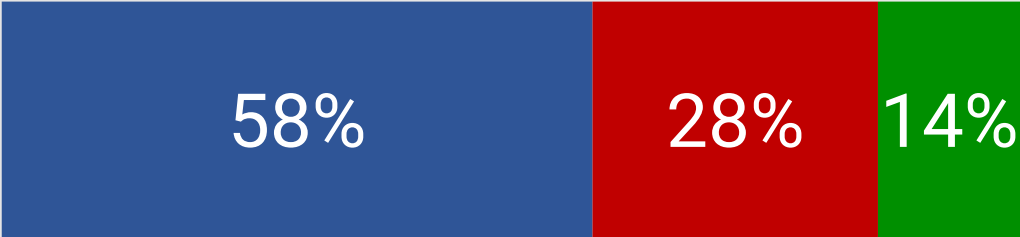

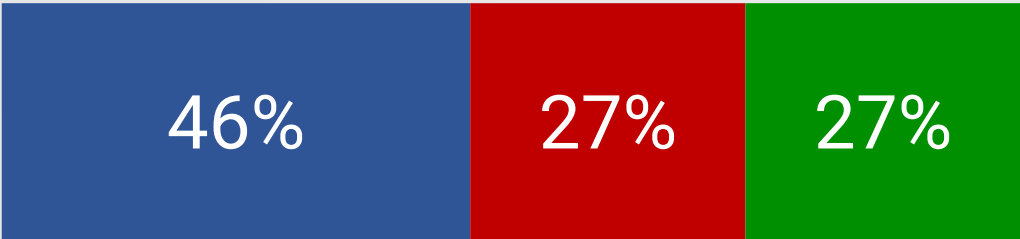

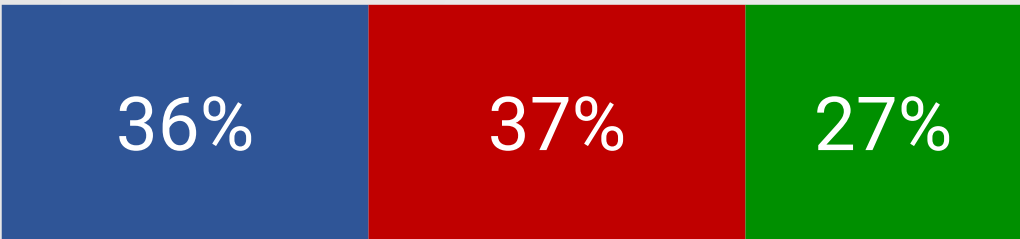
Under a Home Rule form of government, Erie residents are given a greater authority to create laws rather than having a “one size fits all” statutory system.

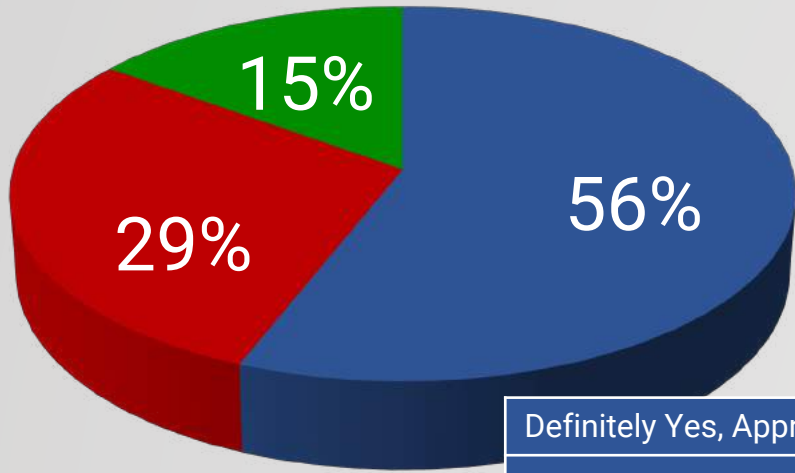

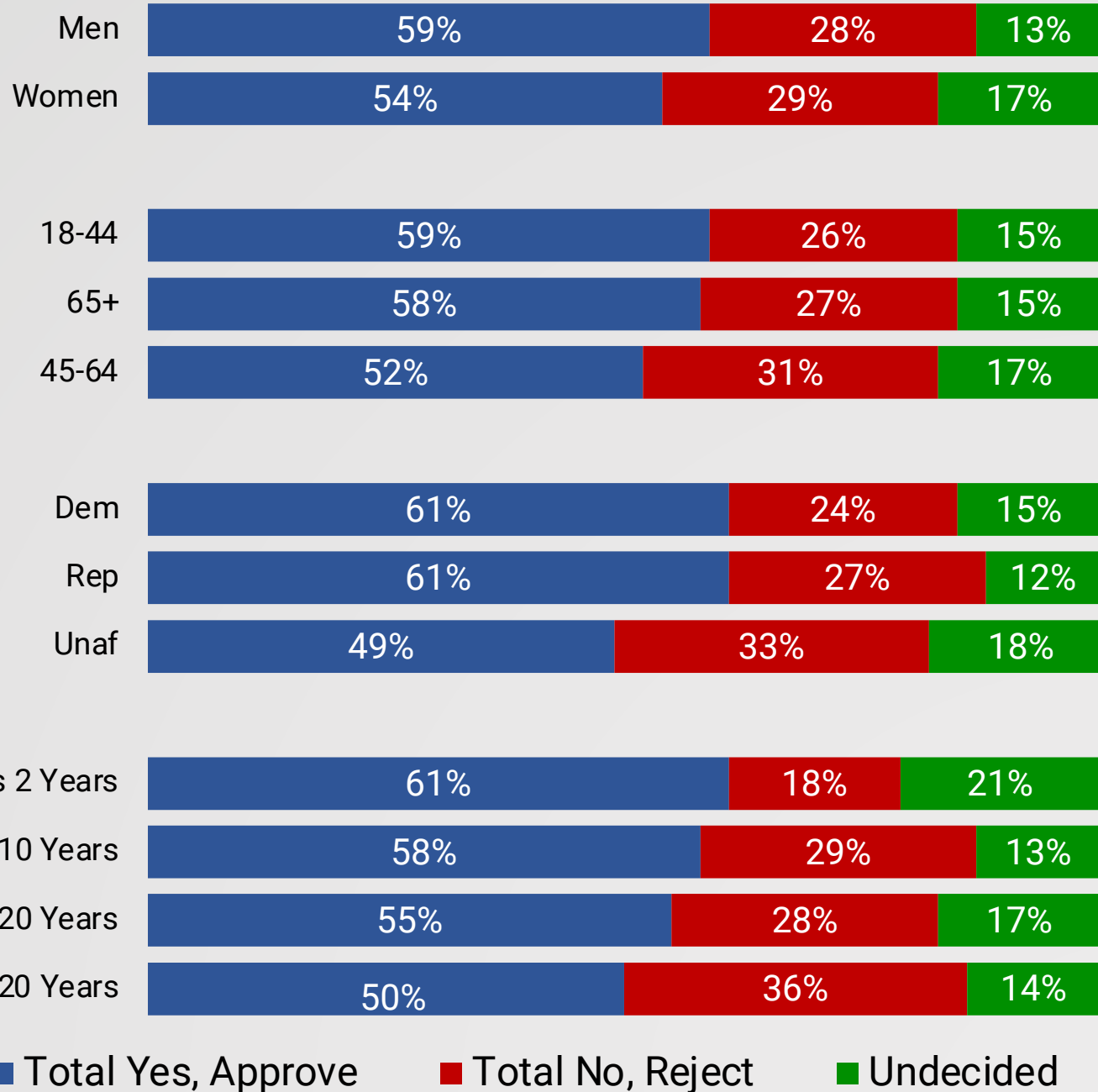

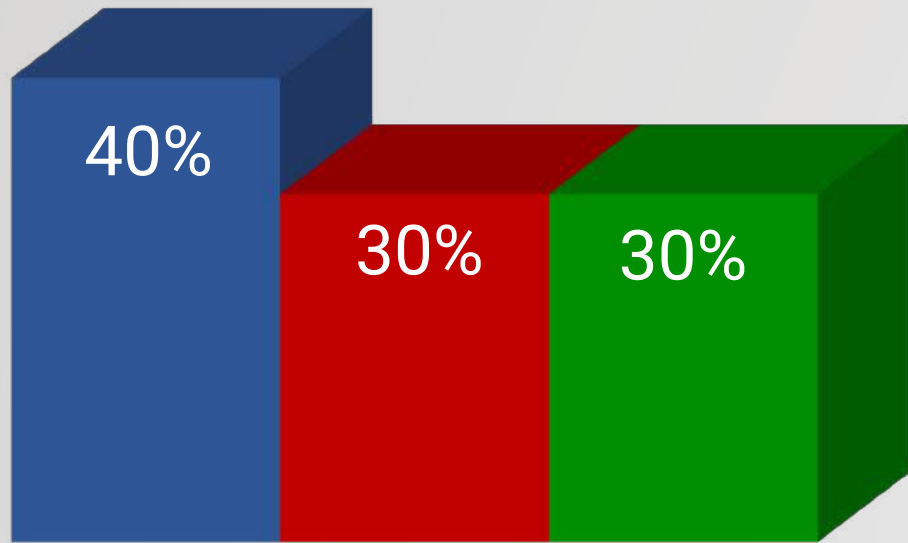

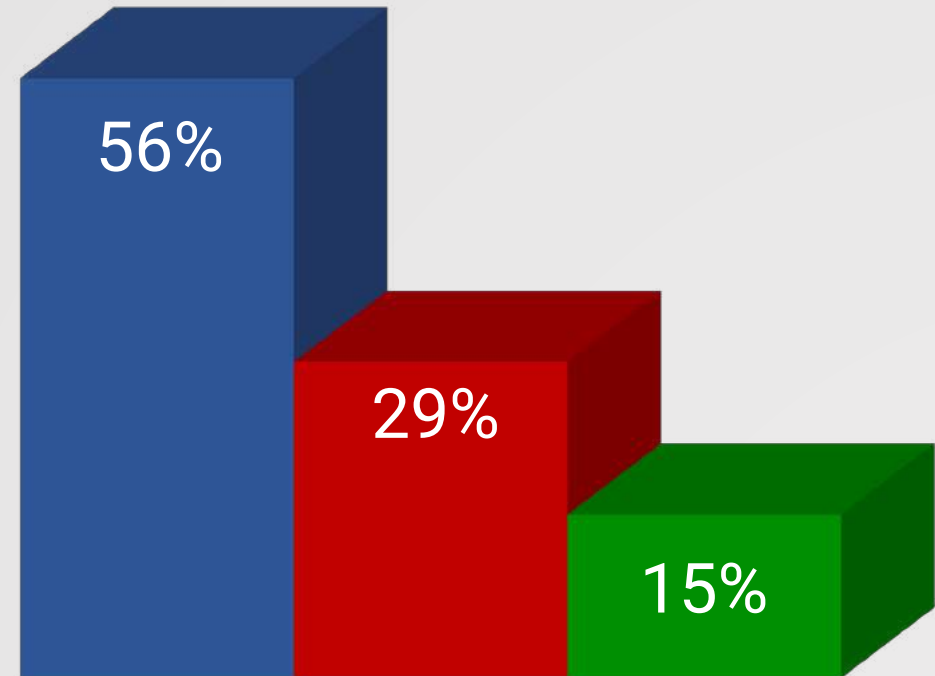
Town of Erie Home Rule Ballot Question Voter Change in Opinion

Why 56% of Respondents Would Vote Yes and Approve A Home Rule Charter Commission

“I would vote yes because we need more flexibility and autonomy in our very fast-growing community.” -**Male, 35-44, Democrat, Less than 2 Years**

“More resident control for specific Erie needs/situations.” -**Female, 45-54, Democrat, 6-10 Years**

“We the people of Erie should be voting for how we want the community governed.” -**Male, 18-34, Republican, 3-5 Years**

“Power closer to home. We know what's best for our town because we live here. Smaller government closer to home all the way.” -**Female, 35-44, Republican, 3-5 Years**

“Erie residents should have a say not one size fits all.” -**Female, 65+, Republican, 6-10 Years**

“93% of Colorado is already there.” -**Male, 45-54, Unaffiliated, Less than 2 Years**

“All government should be local.” -**Male, 45-54, Unaffiliated, More than 20 Years**



Why 56% of Respondents Would Vote Yes and Approve A Home Rule Charter Commission

The top three reasons include:

- 1. Desire for Local Governance and Representation:** Many respondents express a desire for more local control over their town's governance. They believe that residents of Erie understand the community's needs best and should have a greater say in decision-making processes. Home rule is seen as a means to empower citizens and ensure that their voices are heard in shaping policies and laws that directly impact them.
- 2. Flexibility and Adaptability:** Respondents cite the need for Erie to adapt to its growth and changing dynamics. They argue that a home rule charter would provide the town with greater flexibility to address local issues and tailor regulations to suit the community's unique circumstances. This autonomy is viewed as essential for Erie to effectively manage its own affairs and respond to the diverse needs of its residents.
- 3. Distrust of External Governance and Centralized Control:** Some respondents express skepticism and dissatisfaction with the current system of governance, particularly regarding state-level regulations and mandates. They believe that local control would enable Erie to break free from external influence and make decisions that align more closely with the interests and values of its residents. Home rule is seen as a means to reduce bureaucracy and increase accountability by bringing decision-making closer to the community level.

Why 29% of Respondents Would Vote No and Reject A Home Rule Charter Commission

“I prefer our current form of government and what a board of trustees to be in charge of the town.” -**Female, 18-34, Democrat, 3-5 Years**

“I feel like there would be too many people involved and it would interfere with getting anything done. By trying to make all people happy no one would be happy.” -**Female, 35-44, Democrat, 16-20 Years**

“Erie has had to many issues already with it's Mayor and elects. This will just add more issues to our community.” -**Male, 35-44, Democrat, 6-10 Years**

“Given the current Mayor and administration, I have zero faith in the community to actually put people in the seats that are fit for the job. In addition, the current board elected has nearly zero difference of opinions which has been evident over the past few years. In no way would I be comfortable passing more responsibility on to current administration or any elected individuals of the community.” -**Male, 35-44, Republican, 6-10 Years**

“It'll be very costly for the residents, and I don't believe the town can manage itself.” -**Female, 18-34, Unaffiliated, Less than 2 Years**

Why 29% of Respondents Would Vote No and Reject A Home Rule Charter Commission

The top three reasons include:

- 1. Preference for Current System:** Many respondents express satisfaction with the current form of government in Erie and prefer to maintain the status quo. They trust the existing board of trustees and believe that Erie is functioning adequately under the current governance structure.
- 2. Concerns about Competency and Trust:** Several respondents express doubts about the ability of Erie residents or local officials to effectively manage the responsibilities associated with home rule. They cite concerns about corruption, favoritism, lack of competence, and the potential for misuse of power.
- 3. Resistance to Change and Skepticism of Home Rule:** Some respondents oppose the idea of home rule on principle, viewing it as unnecessary, costly, or potentially detrimental to the community. They express a general distrust of increased local control and believe that Erie should remain within the existing governmental framework provided by the state. Additionally, there is skepticism about the motives behind the proposal and concerns that it may be driven by political agendas rather than genuine community needs.

Why 15% of Respondents Are Undecided Regarding A Home Rule Charter Commission

“I don't know enough about it. My initial reaction is no because we live with some extremists in our community who are actively involved in thwarting progress such as racial equity work or school funding. I am very wary of these voices getting more power.” -**Female, 35-44, Unaffiliated, 11-15 Years**

“I've lived in Erie for 3 years and love the direction the town is currently going, but I do not know many of the Erie resident voters. So, I do not trust a change at this point.” -**Male, 45-54, Democrat, 3-5 Years**

“Just want more information. Erie is such a divided town politically, just not sure.” -**Female, 65+, Democrat, 16-20 Years**

“Because I'm not sure what the home rule is exactly. Seems like the people on the committee will make the rules and what if I don't agree with the opinion of the people on the committee.”
-**Male, 55-64, Republican, 16-20 Years**

“Uneducated on what a Home Rule Charter Commission is and the major and minor pros and cons of this form of government.”
-**Female, 45-54, Democrat, More than 20 Years**

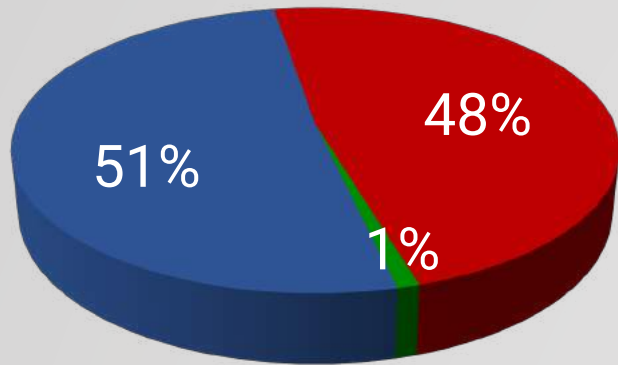
“Need much more detailed information.” -**Female, 65+, Unaffiliated, 6-10 Years**

Why 15% of Respondents Are Undecided Regarding A Home Rule Charter Commission

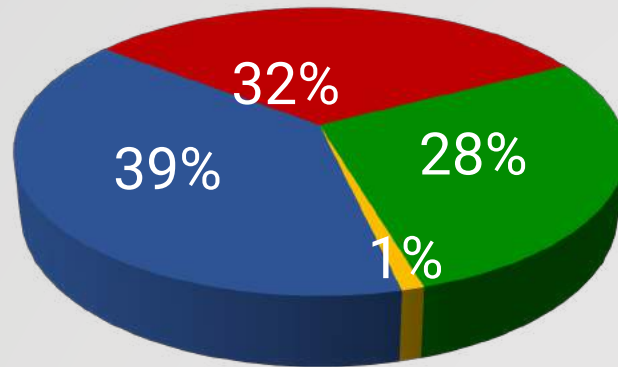
The top three reasons include:

- 1. Lack of Information and Understanding:** Many respondents express uncertainty and indecision due to a lack of understanding about what a Home Rule Charter Commission entails. They feel uninformed about the concept, its implications, and the differences between home rule and statutory governance. Some express a need for more detailed information, examples, and clarity about the potential benefits and drawbacks.
- 2. Desire for Further Research and Education:** Several respondents indicate a willingness to learn more about home rule before forming a decision. They express a need for additional research, education, and access to detailed information about the proposed change. Some mention a desire to understand the process, the roles of residents, and the selection of commission members.
- 3. Concerns and Skepticism about Change:** Some respondents express hesitancy due to concerns about the motives behind the proposal, potential political influences, and fears of unintended consequences. They question the necessity of change, express skepticism about the current administration's ability to implement it fairly, and worry about the impact on taxes, governance, and community representation.

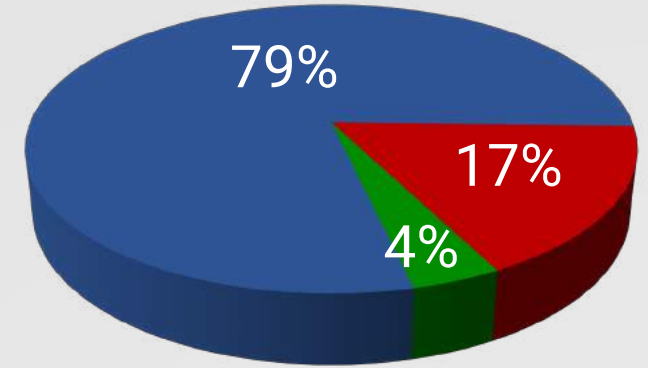
Survey Demographics



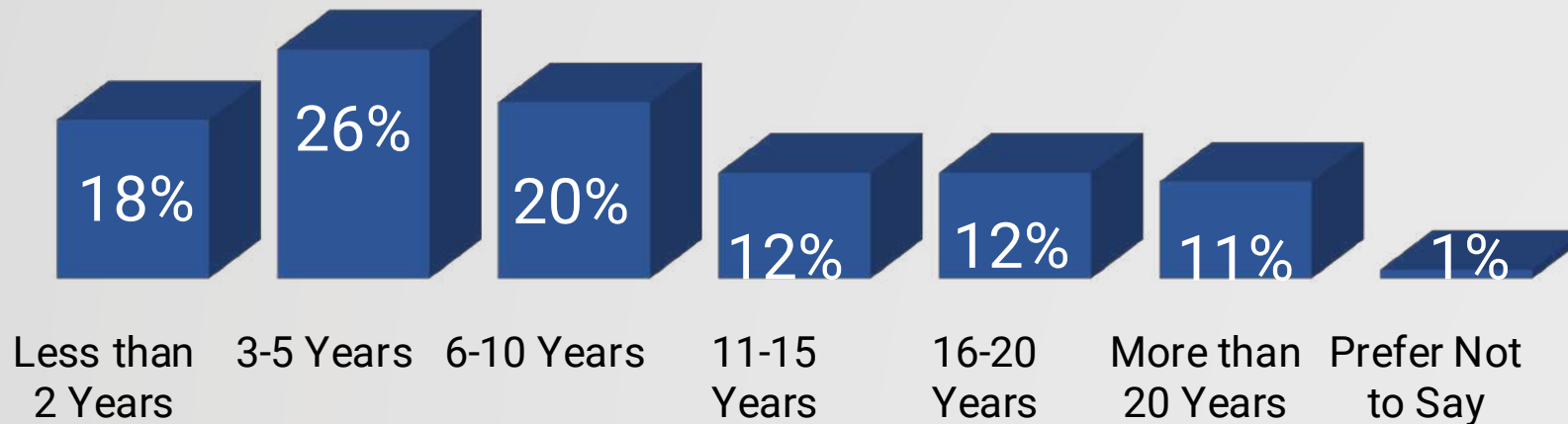

The Roadmap to Home Rule

What do you know about Home Rule? This year, the Town of Erie wants to explore whether it should remain a statutory town or implement Home Rule. Over the next few weeks, we will be sharing information about what Home Rule is, how it could impact you, and ask you to be involved in this process.

So what is Home Rule? Home Rule is a form of government based on a **charter written by residents** rather than following state statute. It is based upon the theory that the residents in the community know best how to solve local issues. A Home Rule Charter could give **you** the chance to determine if Erie should become a city or stay a town, whether the Board of Trustees should become a council, what the term limits are for elected officials, and so much more. Going Home Rule could affect finance, taxation, land use, elections, and administration in Erie.

Ultimately Home Rule is all about YOU! If the community votes to “go Home Rule” in November, the Charter the Town uses to govern the community will be **created by residents** and you get to participate in the whole process. Should Erie Go HOME RULE?

As growth in communities across the Front Range continues exploding, the Town of Erie recognizes its responsibility to provide the best possible quality of life while also ensuring thoughtful growth and fiscal responsibility. 93% of Colorado cities and towns are governed by Home Rule. Erie's Board of Trustees believes now is the time for residents to assess the Town's statutory governing structure and explore becoming a Home Rule town.

To determine if Home Rule is right for Erie, the Board of Trustees would like to make sure the community and its leadership have a shared understanding of:

1. What Home Rule could look like for the Town of Erie?
2. What opportunities and challenges come with a governing change?
3. What steps would need to be taken to shift Erie's government structure?

WHAT IS HOME RULE?

"In Colorado, municipal 'home rule' is a form of government under the control of local citizens rather than state government, with powers and authority derived from the municipality's locally enacted charter and ordinances, rather than state statutes. It affords citizens of cities a towns who adopt a local charter freedom from the need for state enabling legislation and protection from state interference in local and municipal matters."

IN SIMPLER TERMS...

Home Rule is a form of government under the control of local residents rather than state statute.

Home Rule is based upon the theory that the residents of a municipality should have the right to decide how their local problems are solved.

There are many details to help you understand how this might work...keep reading on the flip side.

WHAT IS THE PROCESS FOR GOING HOME RULE?

- In June 2022 the Board of Trustees reviews community feedback and votes whether to add Home Rule and the creation of a Charter Commission for the November 2022 election.
- Those interested in being on the Charter Commission complete a nomination petition and submit to appear on the ballot 30 days of the Trustee vote.
- If ballot passes, the Charter Commission meets and begins creating the Charter and submits to the Town Board.
- November 2023 General Municipal Election includes enacting the proposed Charter.

WHAT IS A CHARTER?

A Charter establishes the Town's form of government and specifies certain rights and responsibilities. As an independent body, the Charter Commission represents residents' viewpoints and considers and recommends appropriate revisions to the Charter, balancing the interests of the Town government and citizens.

WHAT ARE THE POTENTIAL DISADVANTAGES OF GOING HOME RULE?

1. The possibility of a restrictive Charter could lose the flexibility offered by Home Rule.
2. Adopting a Home Rule Charter involves some costs, which can be burdensome to the Town.
3. Some may see the ability of a Home Rule charter to provide more municipal authority as a disadvantage.

HOME RULE COULD IMPACT:

Finance & Taxation

- Allows for broader taxing powers
- Establishes a separate tax base
- Revises budget and adoption procedures
- Establishes debt limitations
- Establishes municipal bond repayment limitations

Land Use

- Allows for greater control over zoning
- Modifies the Planning Commission and Board of Adjustment

Elections

- Established a new process and dates for municipal elections
- Establishes new procedures for initiative, referendum, and recall elections
- Modified process for filing elected office vacancies
- Allows Erie to specify the minimum age for elected officials

Administration/Governance

- Allows Erie to determine its form of government
- Enables Erie to establish its own ordinances and resolutions
- Establishes procedures for regular/special meetings and executive sessions
- Determines municipal court jurisdiction
- Establishes Town procedures for the sale of public property and awarding contracts
- Determines Town qualifications of municipal officers and employees
- Establishes maximum terms for public utility franchises
